HOW TO Alliances and Employers: Working Together for **High-Value Health Care**

January 2014

The business community is uniquely positioned to demand higherquality care at affordable rates. With approximately 149 million nonelderly receiving their health coverage through employers, the business community is a formidable purchaser.ⁱ Yet, despite such strong purchasing power, engaging employers to take a more active role in demanding better value in health care remains challenging. Many Alliances struggle with how to engage and partner with employer groups who do not see themselves as having a role in payment or delivery system reform.

To support Alliances in working with employers to achieve high-value health care, the American Institutes for Research (AIR) developed two short templates on Bundled Payments and Patient-Centered Medical Homes (PCMHs): "How [Alliance] Can Help Employers Implement a Bundled Payment Initiative" and "How [Alliance] Can Help Employers Implement a Patient Centered Medical Home Initiative." These documents provide narratives that Alliances can customize and share with employers to illustrate the benefits of partnering with Alliances to implement these models. These documents can be used in conjunction with the RWJF-funded pieces that focus on the ROI of Bundled Payments and Patient-Centered Medical Homes for employers.ⁱⁱ

How can Alliances use these customizable documents?

Alliances can use these documents to:

- Educate the business community about the Alliance and how the Alliance and employer groups can partner on initiatives to provide high-value care to their employees.
- Initiate engagement with employer groups who have not been previously involved with the Alliance by providing a case for the opportunity to partner.
- Further engage with existing employer partners by highlighting new examples or benefits of partnering with the Alliance.

- 2. Tailor a payment or delivery reform strategy to the regional market's unique needs and health care landscape.
- 3. Structure agreements regarding how premiums would be reduced if the payment reform strategy is successful.
